### GENERAL LIABILITY:

- EACH OCCURRENCE: \$ 1,000,000
- FIRE DAMAGE: \$ 1,000,000
- MEDICAL EXPENSE: \$ 10,000 (ANY ONE PERSON)
- PRODUCTS COMPLETED OPERATIONS: \$ 1,000,000
- GENERAL AGGREGATE: \$ 2,000,000

### AUTOMOBILE INSURANCE (where applicable)

- FOR BODILY INJURY AND PROPERTY DAMAGE FOR NOT LESS THAN \$ 1,000,000  
COMBINED SINGLE LIMIT (MUST COVER ANY AUTO INCLUDING HIRED AUTOS AND NON-OWNED AUTOS)

### UMBRELLA OR EXCESS LIABILITY

- COVERAGE IN AMOUNTS NOT LESS THAN \$ 1,000,000 PER OCCURRENCE.

### WORKERS COMPENSATION AND EMPLOYERS LIABILITY COVERAGE
